- After receiving the monthly payment for the use of Tariff Package 2, the Bank within 2 (two) Banking Days restores the effect of Tariff Package 2 for the Client.

- If the date of making a monthly payment for the use of Tariff Package 2 falls on a non- Banking Day, payments (including Debiting the Account) are made on the Banking Day preceding such non - Banking Day.

- When closing the Client 's Current Account, the monthly payment for the use of Tariff Package 2 for the last month of service is withheld in full, regardless of the availability of funds on the Client's Current Account (s) during the month in which the application was submitted to the Bank account closure.
